With reference to the office Advertisement No. IGNTU/2026/RC-GF/01, Dated 12/02/2026 for the post of Guest Faculty (as per Annexure I), eligible candidates are invited for Walk-in-Interview at the Administrative Building of the University for engagement as Guest Faculty on purely temporary basis with an application on plain paper giving their bio-data and attested copies of Mark sheets/Certificates/Degrees of academic qualifications and experiences along with originals for verification on the date of interview.

Essential Qualifications: As per the UGC/PCI Norms

Salary: Rs. 1500/- per lecture subject to a maximum of Rs 50,000/- per month (as per UGC norms and terms & conditions of University)

Venue: Administrative Building, Indira Gandhi National Tribal University, Amarkantak

General Instructions:-

- [1] This offer for the temporary job in the University will not confer any right to claim regular employment to any post
- [2] The candidates shall be required to join his duties on purely temporary basis in the University within 07 days from the date of offer letter.
- [3] The candidate shall devote his/her whole time to the service of the University and shall not engage directly or indirectly to any other employment or any trade or business or other remunerative work.
- [4] Any absence from duty will amount to proportionate deduction of remuneration.
- [5] The candidate may be discontinued from services at any point of time without assigning any reason. No prior notice in this respect will be required.
- [6] Infringement of any terms and conditions specified herein above, would called for an action.
- [7] In case of any dispute the decision of the Vice-Chancellor will be final and binding.
- [8] Relaxation and Reservation will be given as per GOI/UGC Rules to all the persons belonging to SC/ST/OBC/EWS category.
- [9] University reserves the right to fill or not fill any post if the circumstances so warrant. The number of positions is open to be changed
- [10] No TA/DA shall be paid to the candidates for attending the interview.
- [11] Candidates are advised to satisfy themselves before attending the walk-in-interview that they possess the minimum essential qualifications as laid down in the advertisement.
- [12] The Selection Committee may decide its own method of evaluating the performance of the candidate in interview tuned with UGC norms.

- [13] The prescribed qualifications and experience is minimum and the merely possessing the same will not entitle for any candidate being appointed.
- [14] The University shall verify the documents submitted by the candidate at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a dubious background and has suppressed the said information, then his/her services shall be terminated.
- [15] In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- [16] Number of posts advertised may be treated as tentative. The University shall have the right to increase/decrease the number and/or nature of posts at the time of selection and make appointments accordingly.
- [17] The prescribed qualifications and experience will be minimum and the mere fact that a candidate possessing the same will not entitle for being selected.
- [18] The University may draw a panel in the form of a waiting list to fill up a post. In case a candidate on higher merit regrets to join within a period of 01 month or resigns after joining within a period of 06 months, the offer shall be made to next candidate on the merit, if otherwise in order, to reduce the delay in filling up of the vacancies. Such a vacancy should not be treated as fresh vacancy.
- [19] Consequent upon adoption of self-certification provisions as required by the Govt. of India, the University shall process the applications entirely on the basis of information/ documents submitted by the candidates. In case the information/ documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall lie solely with the candidate.
- [20] The University reserves the right to revise/reschedule/cancel/suspend the recruitment process without assigning any reason. The decision of the University shall be final and no appeals shall be entertained.
